BILLING INFORMATION: Mailed out on the last day of every month

Accounts are considered PAST DUE after the 15th of each month

**If 15th is on weekend/holiday, first working day following 15th is available to make payments prior to being past due

Residential Garbage: Collection on Wednesdays & have polycart out by 7:00am

Sewer Rates: Calculated annually based on water usage in December, January, & February

Convenience Center: Available to Residential customers to drop off trash, large items, metal, etc. *Convenience Center Phone:* 405-375-6553 *Hours: Tuesday-Friday* 9-5; Saturday 8-4

Failure to pay the KPWA Utility charges shall result in the following penalties:

1. Non-payment of charges by due date will be subject to a seven & one-half percent penalty (7.5%) of the past due amount

- 2. Non-payment of charges within a week of the past due date may result in utilities being disconnected
- 3. A \$65.00 fee will be applied to the account for reconnection of services due to a disconnect for non-payment

4. Non-payment of the balance for a period of 30 to 60 days or more shall constitute a termination of this agreement & all rights of the occupant to utility services shall terminate. Upon such termination, the KPWA shall take such actions deemed reasonable & necessary to collect balance owed, including all penalties, plus all court costs & attorney's fees incurred thereafter.

This agreement between the KPWA & the Occupant is hereby understood & agreed by both parties as follows:

The KPWA will provide, subject to the limitations set out in its rules and regulations now in effect or hereafter amended, and subject to availability, such quantity of service as the occupant may desire in connection with the occupancy of the described property.

The occupant agrees to comply with and be bound by the rules and regulations of the KPWA Authority, now in force or hereafter legally supplemented and/ or amended. The occupant also agrees to pay for electric, water, sewer, and/ or solid waste disposal service at such rates, time and place as shall be determined by the Authority. The occupant also agrees to pay any penalties incurred for non-payment of the utility bill.

The occupant is responsible for any charges incurred due to damages inflicted on KPWA property, including but not limited to damage to water and/or electric meter, meter box, main line, transfer line, meter valve and/ or meter lock.

The KPWA shall have final authority in any question of location of service line in its system(s); shall determine the allocation of services to the occupant in the event of shortage and may disconnect services to occupant if allowing a connection or extension to be made to service line that has not been approved by the KPWA or for the purpose of providing services to another user.

In the event the water supply shall be insufficient to meet the needs of the occupant or there is a city wide shortage, the KPWA may limit the water available or put restrictions on usage for certain occupants, as approved by the Board of Trustees and the occupant agrees to follow the necessary restrictions when put in place.

The KPWA has no liability to the occupant for loss of service due to line breaks or disruption of services, weather, catastrophic events, or any other events beyond the reasonable control of the KPWA. The occupant releases the KPWA of any liability for damages caused by the operation of the electric, water, sewer, and/ or waste disposal systems.

By signing this service contract, I agree to comply with and be bound by all rules and regulations of the KPWA and to pay any and all fees, assessments and other lawful amounts chargeable by members. City of Kingfisher Ordinance #876 provides penalty for providing false, fraudulent, incomplete, or misleading information on this application. I swear or affirm under PENALTY OF PERJURY that the information contained in this application is true and complete.
